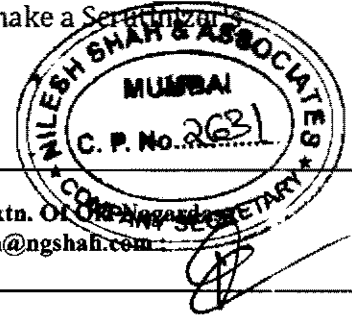

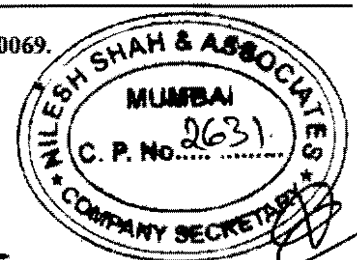
The Shareholders of the Company holding shares on the cut-off date of Tuesday, November 22, 2022 were entitled to vote on the resolutions as set out in the notice.

1. The Company had provided facility of casting vote to the Shareholders of the Company through postal ballot voting process and by remote e-voting on the platform provided by NSDL.
2. The Company had followed the process as required under Section 108 read with 110 of the Companies Act, 2013 and Rule 22 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 read with MCA General Circular No. 14/2020 dated April 08, 2020, MCA General Circular No. 17/2020 dated April 13, 2020 read with other relevant circulars, including General Circular No. 03/2022 dated May 5, 2022 in respect of providing voting facility through postal ballot and electronic means.
3. All Postal Ballot Forms received up to 05.00 p.m. on Tuesday, December 27, 2022, the last date and time fixed by the Company for receipt of the Postal Ballot Forms were considered for my scrutiny for the purpose of this report.
4. The Postal Ballot Forms were kept in my safe custody.
5. The e-voting period commenced Monday, November 28, 2022, 09:00 a.m. (IST) and ends on Tuesday, December 27, 2022, 5:00 p.m. (IST) and the e-voting module was disabled for voting thereafter.
6. At the end of the e-voting period, I have unblocked the electronic votes in the presence of two witnesses not in the employment of the Company.
7. The details containing a list of shareholders who voted 'for' or 'against' the resolution was downloaded from the e-voting website of NSDL.
8. I have scrutinized the votes casted through electronic means and also through physical ballot forms for the purpose of this report.

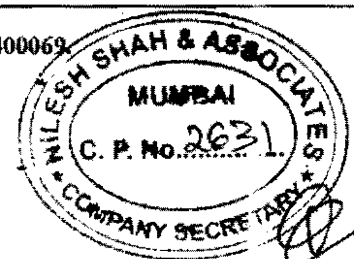



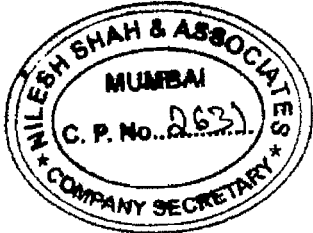
